

Eligibility: Any RLI member who has met the criteria to be considered part of the Military Transition Program (MTP) who intends to pursue the Accredited Land Consultant (ALC) Designation.

Considerations for Selection:

- Membership in RLI
- Membership in RLI's Military Transition Program
- Required: A letter of recommendation from a current REALTORS Land Institute member

## Limitations:

- Only one scholarship per person for one course registration up to a maximum award of \$535. Unused funds do not carry over for a second course.
- Scholarships are prohibited from being used for a course that has already been paid for. If you are concerned about course availability, please contact RLI's CEO or Education Manager.
- Scholarships must be used within 12 months from date of approval
- MTP Scholarships are awarded separately from LEF's Education Scholarships

Deadline: Applications should be submitted no later than the 15<sup>th</sup> of the month prior to the start of a new course.
