

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

As it relates to my involvement in the 2021 National Land Conference, March 14-17, at the Hyatt Regency Hotel in Louisville, KY:

- I am aware of the contagious nature of the COVID-19 virus disease and the risk that I may be exposed to or contract the virus by being at the Louisville Hyatt Regency Hotel or participating in the National Land Conference, and that that risk may include serious illness, personal injury, permanent disability or death.
- I acknowledge that, while RLI, the Louisville Hyatt Regency Hotel, and other contractors involved with the National Land Conference have implemented preventative measures to reduce the spread of the virus, RLI cannot guarantee that I will not become infected by the virus and that this risk may be inadvertently compounded by the actions, omissions, or negligence of others, including RLI members, volunteers and staff.
- I acknowledge that I am voluntarily entering the Louisville Hyatt Regency Hotel and other conference venues to participate in the National Land Conference and its related activities. I agree to accept and assume all risks of personal injury, illness, disability or death related to the disease arising from my involvement in the National Land Conference and its related activities, whether caused by the negligence of RLI or otherwise.
- I hereby expressly waive and release any and all claims, now known or hereafter known, against RLI, its officers, directors, employees, exhibitors, members, volunteers and contractors on account of injury, illness, disability or death arising out of or attributable to my being at the hotel or engaging in the 2021 National Land Conference and being exposed to or contracting the virus, whether arising out of the negligence of RLI, or other individuals or organizations involved with the 2021 National Land Conference. I agree not to make or bring any such claim against the RLI or other individuals or organizations involved with the 2021 National Land Conference, and forever release and discharge RLI and other individuals or organizations involved with the 2021 National Land Conference from liability under such claims.
- I am familiar with federal, state, and local laws, orders, directives, and guidelines related to COVID-19. I will comply with all such orders, directives, and guidelines while attending the 2021 National Land Conference at the Louisville Hyatt Regency Hotel and other conference venues, March 14-17, 2021, including requirements related to hand sanitation, social distancing, and use of face coverings.
- I agree not to enter the Louisville Hyatt Regency Hotel if I am experiencing symptoms of the virus (such as cough, shortness of breath, or fever) or if I have a confirmed or suspected case of the disease, or if I have come in contact in the last 14 days with a person who has been confirmed or suspected of having the disease.
- I shall defend, indemnify, and hold harmless RLI, its officers, directors, employees, exhibitors, members, volunteers and contractors against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind rising out or resulting from any claim of a third party related to the disease due to my engaging in the 2021 National Land Conference at the Louisville Hyatt Regency Hotel and other conference venues March 14-17, 2021.
- I acknowledge that I have read the "Release of Liability and Assumption of Risk" document above in its entirety and I register for the 2021 National Land Conference with the further acknowledgement that I agree to abide by all the conditions detailed in this document.
